

## Sample RFLE 3

### Scenario:

On 7/29/2016, Johnny R. Smith (B/M, DOB 6/14/1990) was found deceased from multiple gunshot wounds after units responded to a call of multiple shots fired. Additional responding units found the below listed suspects running from the scene, 3 blocks away. The two suspects were detained and arrested on outstanding warrants for malicious wounding in an unrelated incident. A police dog was used to search the route between the shooting scene and the location the suspects were encountered and a firearm was recovered in some tall grass. A ball cap was also recovered in the street a half block from the victim.

### Suspects:

Michael A. Brown (B/M, DOB 11/17/1986, SID# VA1234567X)  
Leonard T. Jones (W/M, DOB 8/23/1987, SID# VA7654321X)

### Recovered from scene:

Items 1-2, 10: 3 bullets  
Item 3: Beer can near victim  
Items 4-9: 6 cartridge cases (approximately 40 feet from victim)  
Item 11: Ball cap  
Item 12: Firearm (Sig Sauer 9mm)  
Items 13-14: Primer Residue Kit collections from each suspect

### Recovered from suspects at lock up:

Items 15-16: Buccal swabs from each  
Items 17-18: Known fingerprints from each

### Recovered from OCME at autopsy:

Items 19-21: 3 bullets  
Items 22-26: Victim clothing

### Evidence submission note:

The beer can and victim clothing are not considered to have probative value at this time so are not being submitted to the laboratory. Because there are SID #s available for the suspects, it is not necessary to submit their known fingerprints. Without SID #s, it would be necessary to submit the known fingerprints.
